Consignment Term - 90 Days. This may be shortened at any time due to seasonal changes. Items sold between days 1-60 will result in a 50%/50% Split, Items sold between days 61-90 will result in a 25%/75% between consignors & Dragonflies & Ladybugs respectively. It will be the sole responsibility of the consignor to contact Dragonflies & Ladybugs at the end of their Contract Date. 24 Hour Notice must be given within 7 days of contract end date. Any Unclaimed items that have exceeded their policy term will become the property of DRAGONFLIES & LADYBUGS to be disposed of at their discretion. If you wish to pick any items up before your Contract End date, you will be provided a list of available items and it will be the Consignors responsibility to collect the items off any racks/shelves etc.

Payments to Consignor - will occur by the 15th day of each month. Consignor will receive payment for any items sold during the previous month's sales. Checks for less than \$20.00 will not be written and balance will be carried forward. It will be the responsibility of the consignor to pickup any monthly check being generated. Check(s) that are mailed will be accessed a handling charge of \$1. There is a \$5 seasonal handling fee that will be deducted from your 1st check issued each Season (twice a year). Your balance may be applied to an in store purchase at any time. Unclaimed Consignor's Balances, after 60 days from Contract end date, will become the property of DRAGONFLIES & LADYBUGS. Dragonflies & Ladybugs reserves the right to seek and retain a buyers fee.

Liability Waiver - DRAGONFLIES & LADYBUGS, its agents, employees, and volunteers shall not be responsible for theft, loss of, or damage to any consigned merchandise. Consignor further agrees to hold harmless DRAGONFLIES & LADYBUGS, its agents, employees, and volunteers from any potential claim of reimbursement for any said theft, loss of, or damage to any consigned merchandise.

Pricing will be done at the discretion of Dragonflies & Ladybugs; Sales may occur at any time. DRAGONFLIES & LADYBUGS reserves the right to refuse any item that we believe is not suitable for resale. DRAGONFLIES & LADYBUGS reserves the right to make policy changes at any time.

Consignor represents & states that he/she is the owner of all goods placed for consignment & that the goods are saleable &/or free & clear of liens or other claims.
